Legacies

Legacy income can be very important for a small charity like TWAM. It ensures that TWAM can continue to help in the future, developing its services to keep pace with the changing needs of people within the Third World. Currently only 1 in 7 Wills contains a charitable bequest and many people fail to make a Will at all. Here is a sample form of wording for those who would like to prepare a bequest in favour of TWAM:

'I bequeath to Tools with a Mission (a tenth/a quarter/a half, etc.) of the residue of my estate, free of tax and duty, to be applied to the general purposes of the said Tools With A Mission, and I declare that the receipt of the Honorary Treasurer or other authorised official for the time being of the said Tools With A Mission shall be sufficient discharge of the bequest.'
